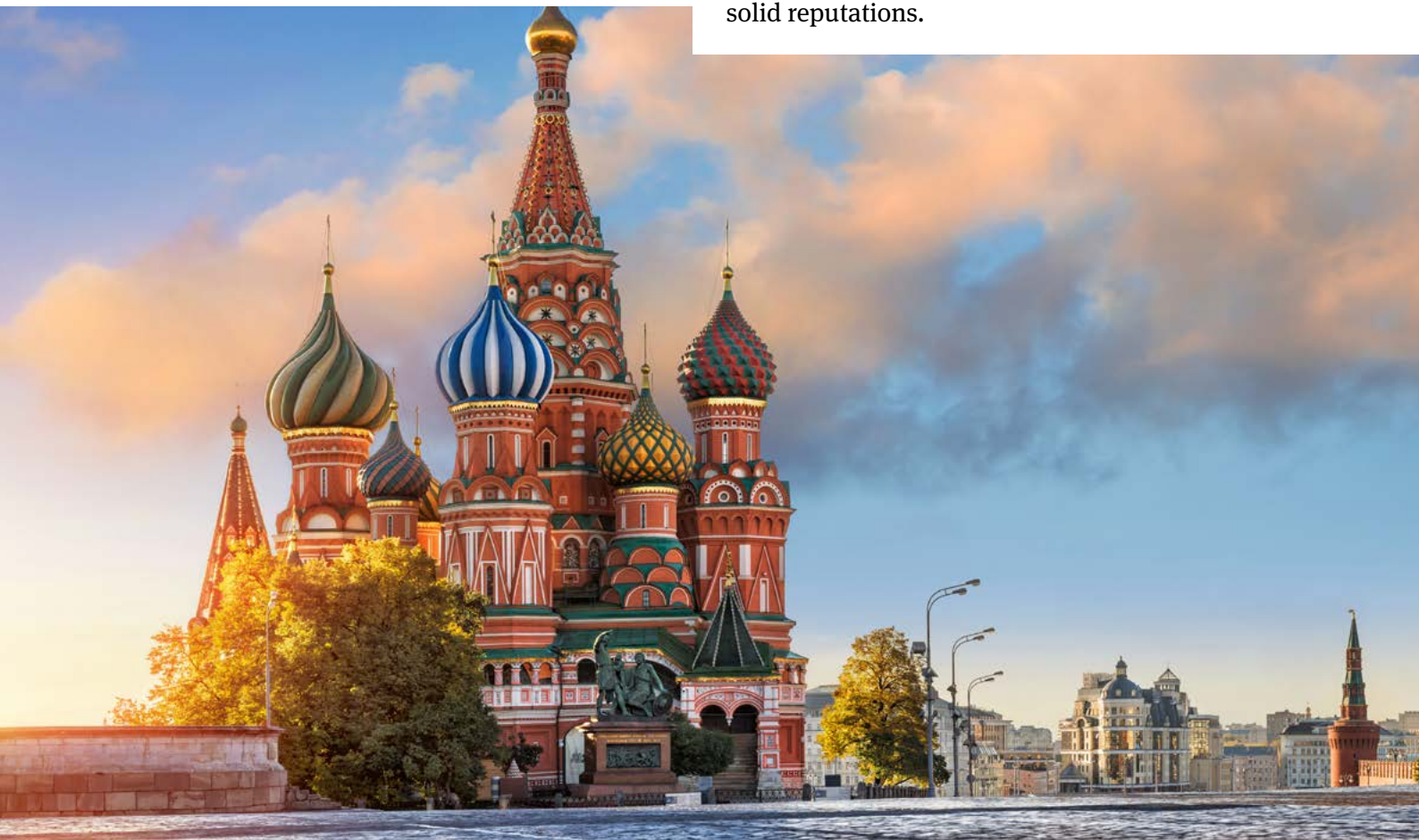


# About Russia
